

## “GNARLY HEAD WICKEDLY BOLD HALLOWEEN” SWEEPSTAKES - OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. NO ALCOHOL IS INCLUDED IN THE PRIZE(S).** This Sweepstakes is sponsored by Gnarly Head Wines, 12001 S. Highway 99, Manteca, CA 95336 (the "Sponsor").

- 1. ELIGIBILITY.** Sweepstakes participation is open only to eligible legal residents of the United States and the District of Columbia (excluding UT and where prohibited or restricted by law), who are 21 years of age or older at the time of entry. The “Gnarly Head Wickedly Bold Halloween” Sweepstakes (“Sweepstakes”) begins 12:00AM Pacific Time ("PT") on September 1, 2018 and ends 11:59:59PM PT on November 15, 2018 ("Entry Period"). Entries must be received by 11:59:59PM PT on November 15, 2018. Entries may sometimes herein be referred to as an “Entry” or “Entries”. All Entries become the property of Sponsor and will not be acknowledged or returned.

The following individuals are not eligible: employees, contractors, directors and officers of Sponsor and each of its respective parent, affiliates, subsidiaries and web-design, advertising and promotion agencies, fulfillment, judging or other agency involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively, "Parties"), and the immediate family members (parent, spouse, sibling, child, and their respective spouses or "step" of each, all lineal descendants, including those by adoption, regardless of where they reside) and those living in their same households whether or not related. Licensed distributors or retailers of alcoholic beverages, state or local alcohol beverage agencies and their employees, are not eligible. Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who, within the past six (6) months, performed services for Sponsor, agency or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying the prize, and/or their respective parent, affiliates, subsidiaries, and successor companies, and immediate family and household members of such individuals, are not eligible to enter or win. ### 2. TO ENTER.

#### TEXT

Enter using your SMS-enabled mobile phone by texting “GNARLY” to shortcode 797979. You (sometimes referred to herein as an entrant) will receive a reply text message(s) with a link to [www.gnarlyhalloween.com](http://www.gnarlyhalloween.com), where you will submit your official entry, including your full name, zip code, telephone number, email and birthdate. Entrant must confirm they are 21 years of age or older. Entrant must complete all fields in the online entry form or entry will not be accepted. Except as otherwise provided in these Official Rules, limit one Entry per person or email address for the duration of the Entry Period. Participants must have a mobile phone with text messaging and web browsing capabilities, as may be applicable, to enter and may incur a standard text message and/or data charge from their wireless service provider for each message sent and received. Check with your wireless service provider for details on these and other applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. Texting entrant must be the authorized account holder of the account from which the Entry is submitted. Entrant understands the text message sent is considered an electronic signature agreeing to the terms and to giving consent to receive automated text messages from Sponsor.

If you do not have a computer or other device to access the Internet, many public libraries offer free access to computers and the Internet.

#### EARN ADDITIONAL ENTRIES ONLINE

- b. Click to share the Sweepstakes on Twitter with the hashtags #GNARLYHALLOWEEN and #SWEEPSTAKES and earn one (1) additional entry for the duration of the Sweepstakes.
- c. Click to share via email and earn one (1) additional entry for the duration of the Sweepstakes.

Each entrant may earn up to a maximum of four (4) entries during the Entry Period, which includes registration and sharing on Instagram, Twitter and/or email. Entrant agrees to comply with these Official Rules. The Sweepstakes and all content thereof is intended only for those who are of legal drinking age or older. Entrant should not share content with those who do not meet legal drinking age requirements. Entries become the property of Sponsor and will not be returned or acknowledged except as may be provided herein.

By submitting an Entry, entrant irrevocably grants Sponsor and its affiliates, legal representatives, assigns, agents and licensees, the unconditional and perpetual right and permission to reproduce, encode, store, copy, transmit, publish, post, broadcast, display, publicly perform, adapt, exhibit and/or otherwise use or reuse (without limitation as to when or to the number of times used), the Entry, including but not limited to, the right to use entrant's name and picture/photo ("Likeness"), and/or statements regarding his/her participation in this Sweepstakes (with or without using the entrant's name) in any and all media without limitation as to time or territory, and without additional compensation or approval from the entrant or any other party. Entrant expressly waives any intellectual property rights, privacy/publicity rights or other legal or moral rights that might preclude the Sponsor's use of the Entry, and agrees not to sue or assert any claim against the Sponsor for the use of the Entry or entrant's Likeness or statements.

By participating in the Sweepstakes, entrant agrees that Sponsor shall have the right to use all personal information provided to Sponsor in accordance with the privacy policy found at [www.gnarlyhead.com](http://www.gnarlyhead.com). At the time of entry, entrants may be given the opportunity to opt-in to receive further communications from Sponsor. Entrants are not required to opt-in and opting in will not improve the odds of winning. No more than four (4) messages per month, and in some months there may be none. Entrant may text STOP to 797979 to stop receiving text messages.

### **3. GENERAL CONDITIONS.**

Entrant agrees to indemnify and hold Sponsor, its agencies and Parties and their respective affiliates, officers, directors, agents, co-branders or other partners, and any of their employees (collectively, the "Indemnitees"), harmless from any and all claims, damages, expenses, costs (including reasonable attorneys' fees) and liabilities (including settlements), brought or asserted by any third party against any of the Indemnitees due to or arising out of the entrant's Entry, or the entrant's conduct in creating an Entry or otherwise in connection with this Sweepstakes, including but not limited to claims for trademark infringement, copyright infringement; violation of an individual's right of publicity or right of privacy; or defamation. Sponsor reserves the right, at its sole discretion, to disqualify any individual it determines to be tampering with the Entry mechanism, to be violating these Official Rules or to be acting in a disruptive manner.

Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

- 4. PRIZES.** Ten (10) winners will each receive one (1) gift card to throw their own 'Gnarly Party'. Approximate Retail Value ("ARV") of each gift card is \$500.00. Total ARV for all gift cards is \$5000.00. Alcohol is not part of the prize. Winners must be 21 years of age or older.

No substitution or cash equivalent of prize is permitted except at Sponsor's sole discretion. Winner is responsible for any and all federal, state and local taxes or assessments, as well as any forms as may be required by said taxing authorities (e.g., IRS Form W-9). Any person winning over \$600.00 in prizes will receive an IRS Form 1099 Miscellaneous from Sponsor for the calendar year in which any prize is awarded. Odds of winning depend on the number of eligible Entries received.

- 5. WINNER SELECTION.** Potential winners will be selected in a random drawing from all eligible entries received on or around November 20, 2018. Winners will be drawn by an independent judging organization whose decision with respect to the selection of the winners and the interpretation of these Official Rules and regulations will be final. Winners will be notified by telephone and/or email. Winners will have 48 hours from time of initial notification to respond. If a respective winner does not respond within the 48 hours or an email notification is undeliverable after up to three (3) attempts, a new winner may be selected. Winners will each be required to sign and return an Affidavit of Eligibility, Acceptance of Conditions, and Liability/Publicity Release or similar (where allowed by law) within three (3) calendar days. If potential winner does not return fully executed paperwork within three (3) calendar days, winner may be disqualified and an alternate winner may be selected.
